In order to be eligible for co-option as a Town Councillor, you must be a British citizen, an eligible Commonwealth citizen or a citizen of any member state of the European of the Commonwealth or the European Union; and on the date of the poll or election, 18 years of age or over; and be able to meet one of the following qualifications set out below: Please tick which one applies to you: a) I am and will continue to be, registered as a local government elector for the parish from the day of my nomination onwards; or b) I have, during the whole of the 12 months preceding the date of my co-option, occupied as owner or tenant, land or other premisesin the parish; or c) My principal or only place of work during those 12 months has been in the parish; or d) I have during the whole of the 12 months resided in the parish or within three miles of it. 2. Please note that under Section 80 of the Local Government Act 1972, a person is disqualified from being elected as a local councillor or being a member of a Local Council if they: a) Hold any paid office or employment of the local council (other than the office of Chair or vice-chair) or of a joint committee on which the council is represented; or b) Is a person who has been adjudged bankrupt or has made a composition or arrangement with his/her creditors (but see below); or

c) Has within five years before the day of election, or since his/her election, been convicted in the UK, Channel Islands or Isle of Man of any offence and has been sentenced to imprisonment (whether suspended or not) for not less than three months without the option of a fine; or

d) Is otherwise disqualified under Part III of the Representation of the People Act 1983 for corrupt or illegal practices; or

e) Is subject to the notification requirement of or under Part 2 of the Sexual Offences Act 2003, and the ordinary period allowed for making an appeal or application in respect of the order or notification has passed.

**Bankruptcy in itself is not a disqualification.** If you have been adjudged bankrupt by a court in England, Wales or Northern Ireland, you are not disqualified on that basis. However, you are disqualified if you are currently subject to any of the following:

- an interim bankruptcy restrictions order
- a bankruptcy restrictions order
- an interim debt relief restrictions order
- debt relief restrictions order made by a court in England or Wales.
